- g. An affidavit on Rs.10/- non judicial stamp paper by the individual faculty member selected by the institution. Details should be filled in by every faculty member selected in the prescribed format.
- Educational & Professional qualification certificates of all teaching staff showing their eligibility for appointment as per the NCTE norms and experience certificate of the Principal/HOD.
- i. FDRs duly converted in favour of joint name of the Society/Trust/Institution and Regional Director ERC, NCTE, Bhubaneswar with Joint operation Mode: 'AND'. A letter to the concerned bank is being sent authorizing the bank on behalf of Regional Director for the conversion in the joint name.
